Your support made it possible for the participants to stay in cabins, play in a treehouse, ride on a pontoon boat, and go horseback riding all at no cost to the campers. For families that struggle with adequate funds, accessible recreation areas, and the many challenges of a chronic or terminal illness, these camp sessions are often an opportunity of a lifetime.

Each session, we request that the campers complete an evaluation to help us improve. We look forward to reading the responses, as the families write notes about their favorite activity, the joy on their child's face, and how wonderful it felt for the adults to be at a place that understands their needs. The children enjoy spending time with friends (new and old) who share the same challenges, and the parents appreciate the opportunity to relax in the wilderness or visit with other adults in similar situations. What a pleasure that, with your support, our Camp gets to be a part of strengthening this community!

This summer, each camping session welcomed an average of 65 campers and all 16 cabins units were occupied. Over 65% of our campers came from the western side of Washington State this year and 60% of the family members were under the age of 10. We were able to serve approximately 650 campers before our season was prematurely ended in July due to a fire in the area that cut off all power and the majority of the access points to the Camp. Although we were able to serve fewer than our anticipated groups (and goal of 1,400 campers), we have offered the remaining groups priority placement for the 2025 camping season and are looking at ways to expand the number of sessions.
