In the spirit of amplifying and celebrating women's leadership, we travel to Olympia, the Washington State capital, to honor and celebrate the work women are doing in judicial, legislative, and executive branches, and in government agencies.

This year we partnered with the <u>Washington State Women's Commission</u>, the <u>KD Hall Foundation</u>, and the <u>Interagency Committee of State Employed Women</u>.



Over **170 people** attended Women at the Capitol this year! Our guests were from all backgrounds, industries, ages, races, and communities. The day offered people the opportunity to meet with elected officials, learn more about their own legislators, and see how the government works. Participants got to connect and speak with elected officials, Supreme Court Justices, state employees, and civic leaders who are working on issues most important to women in Washington.

We invited people from all over Washington State and for those coming from King County we provided transport from Seattle, Bellevue, and Des Moines.

Upon arrival we were welcomed at the Governor's Mansion for afternoon tea.







We hosted a discussion with our State Supreme Court Justices:

- Chief Justice Gonzalez
- Justice Stephens



- Justice McCloud
- Justice Yu

Some of the questions and topics we discussed were about what a day in the life of a Justice looks like, what they feel are their most important responsibilities, what parts of law are protecting and advancing democratic ideals and women's rights, and how does that court build trust with its citizens. It was an insightful conversation with lots of participation from the audience.

In the afternoon guests chose between a private tour of the Capitol or a panel discussion on Co-creating the Future of Gender Pay Equity. The panel took a deep dive into the current state and the future vision for pay and job equity for women in our State. Panelists included:

In the late afternoon and evening we had the opportunity to observe the legislative process in action as House Bill 1263 –known as the Keep Our Care Act—was debated on the house floor.

We then hosted a reception to recognize our 2024 Women at the Capitol Honorees. Our keynote speaker was Representative Tarra Simmons. Who joined us from the house floor to speak about the importance of organizations like Center for Women & Democracy and her work throughout the legislative session.





After the keynote, we honored the following for their work supporting and furthering women's and girls rights in Washington state.

- Rep. Jamila Taylor For her work introducing a budget proviso to commission a study and convene a taskforce on occupational segregation and the economic status of women in our state
- Rep. Monica Stonier For her work sponsoring crucial legislation on eliminating child marriage and providing sanitary conditions for workers on construction sites who are menstruating or expressing milk
