The Family Justice Center Foundation Fund, a component fund of the Greater Tacoma Community Foundation (www.ficfoundationfund.com), was a recipient from the Tulalip Tribes Charitable Fund. This generous award was used for the Victim Services Fund at the Crystal Judson Family Justice Center. This serves as a final report regarding how the award was utilized.

As a result of the Tulalip Tribes Charitable Fund's support, victims of domestic violence and their children were provided with food, emergency shelter, transportation, and relocation assistance. These families are some of the most vulnerable in our community. The Victim Services Fund provides these emergency resources where it has been determined, by experienced advocates, that it is an instance of high-lethality, and the victim has no other resources available to them. It is the goal of the agency to intervene and help prevent additional harm to the family.

In 2023, the Center was visited 1,602 times by survivors. During the duration of this funding, the Victim Services Fund was utilized 1,467 times to provide emergency support to survivors and their children. Services provided through this funding included rental assistance, lock changes, emergency motel stays, transportation assistance, and food assistance. This kind of support can truly make the difference in whether a client stays in an abusive situation or has the ability and support to move forward to a life of safety and stability.
