Dear Tulalip Tribes Charitable Contributions Fund,

In August of 2023, you generously awarded a grant of for Patient Visits to Safe Harbor Free Clinic. I would like to take this opportunity to share with you how we used this grant to provide services for our patients.

In 2023, we served 1234 patients in our same-day and specialty clinics and saw an 8% increase in new patients. Our Stanwood clinic offers multiple specialty services and our Smokey Point clinic is running steadily on Thursday evenings. Patient visits at our Smokey Point clinic have taken time to build into a steady number each week but we are now consistently seeing 4-6 patients each week. While this may not seem that large of a number, it is showing us that we are now reaching an expanded population of people who need access to free healthcare, many of whom are new patients to us and are immigrants to our country. As word spreads through their communities, we expect this number to increase.



The grant you awarded to us for patient visits has provided support for the many patients who, without the help of medical insurance, came to us for care. It provided several free blood pressure cuffs for our patients, foot care for our diabetic patients, respiratory support for those with Asthma, COPD or other respiratory

conditions. We were able to offer more patient follow up support from staff who work directly with patients to help them achieve improved health outcomes.



Seeing an oncologist would be cost prohibitive without our ability to provide referrals to outside organizations that specialize in the needs of uninsured people who require treatment for their health conditions.

This gives hope and healing to the lives of all who come to us for their care.
