Dear Marlyn:

This letter serves as Turning Pointe's report for the Q4 2022 Grant award from the Tribe's Charitable Contributions Fund.

First, we want to thank you for your generous award which was used to provide parenting classes for our clients.

In fall and summer of 2023, **17 clients** total attended parenting classes.

Turning Pointe Survivor Advocacy Center partnered with Juli Jager, M Ed., who was able to provide free, accessible, trauma-informed parenting classes. The classes were hosted weekly and were offered as a hybrid model. This means the clients may also attend the class via zoom. The option to attend virtually allowed for the removal of barriers such as transportation or needing childcare to attend. Additionally, the hybrid model allowed our clients to stay connected to their support group and youth advocate even after they exited the shelter. All feedback received from clients about the parenting class was positive. We even had a client who consistently attended parenting classes for a year and a half! The classes offered not only practical tools for caregivers but a place for survivors to build lifelong healthy connections with woman who have experienced similar things.

Here is a client story about parenting classes "During parenting support class, one of the parents told Juli, Dee, and I that we were her angels, and expressed gratitude for having us as a resource. This survivor had been coming consistently to the classes and talking about her experience in raising her children post living with her abuser. Juli, the parenting class instructor, offered her presence, knowledge, and guidance to this parent and it seemed that just having someone to listen aided her in times of hardship."

We plan to continue with the parenting classes in 2024 and look forward to the opportunity to partner with the Tulalip Tribe again.

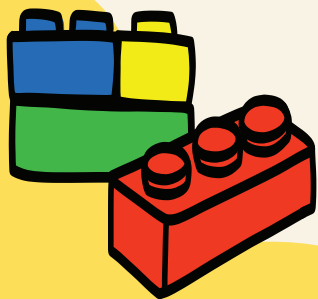
Parenting Support Group
